



## Buyer Mission Legal & Sustainable Timber from PERU: July 1<sup>st</sup> to 7<sup>th</sup>, 2018.

### Meet reliable Peruvian producers of decking, flooring and sawn timber in FSC quality!

The Peruvian Government, in cooperation with the Import Promotion Desk (IPD), organizes a Buyer Mission to Peru from July 1<sup>st</sup> to 7<sup>th</sup>, 2018. By joining this mission, up to 10 importers will have the opportunity to meet **9 suppliers of decking, flooring and sawn timber in three regions (Lima, Madre de Dios, Loreto)**, to visit their production site and to have individual b2b talks during the *Industria Peru* business matchmaking.

The suppliers have been selected by IPD and PROMPERU (Peru Export and Tourism Promotion agency) based on company visits, product quality, capability and capacity for export, access to and use of FSC timber. In the context of Peru, we consider **FSC certification** as an essential requirement to insure the legality of the timber.

### YOUR BENEFITS:

- Visit reliable suppliers of legal and sustainable timber in Peru
- Obtain information about the supply chain from concession to processing
- Get to know relevant associations and organizations in Peru
- Network with other CEOs and purchasing managers from European timber importing companies

### OUR SERVICES:

- All logistics in Peru (national flights, transportation to the companies, accommodation) will be organized by PromPeru and its partners.
- The buyer mission will be accompanied by PromPeru and IPD representatives
- As an option, we offer you to extend the mission by 1 day in order to spend one night in an FSC certified concession in Madre de Dios
- On a case by case basis, PromPeru offers to sponsor the international flight ticket and/or two overnight stays in Peru (in order to be considered, please register separately for the *Industria Peru*)

### REGISTRATION AND PARTICIPATION FEE:

- **Participation fee: 1.200,- EUR per person** (1.500,- EUR per person for the extended mission) / includes all national flights, accommodation, transportation in Peru, and lunches / will be organized and invoiced by a travel agency based in Germany.
